Now therefore the Buyer and Seller hereby agree to the following:

- The buyer shall have the puppy examined by a veterinarian within two (2) business days of delivery (Examination).
- Should the Examination disclose any congenial/genetic life threatening defect, the Buyer shall have three (3) additional business days to get a 2nd opinion from a non-related veterinarian from a separate non-related clinic. If the 2nd vet confirms the diagnosis and it is a condition covered in the health guarantee the buyer must return the aforementioned puppy to the Seller. Seller shall provide Buyer with a replacement puppy of the Buyers choice of at least equal value. Such return from buyer must be conducted within seven (7) business days after the 2nd veterinary examination as contemplated above, and must be accompanied by a signed statement from said veterinarians summarizing the Examination and detailing any life threatening: defects, diseases, or genetic or congenital defects. Buyer agrees to notify Seller in case of any such medical issue. If such hereditary condition is life threatening the dog will be replaced with a puppy of at least equal value.
- Seller warrants that the dog is free of congenial/genetic defects of a life threatening nature for TWO (2) years from the dog's date of birth. No money paid at any time is refunded. Replacement puppy warranty only. If buyer chooses to pass on their French bulldog at any time for any reason all money paid is forfeited.
- The Seller sells puppy as a pet of show quality prospects, although Buyer understands that no GUARANTEES can be made in this regard. In the future, should the Buyer be unwilling to continue ownership of Dog, the Buyer shall contact the Seller before any action is taken.

BLUEGRASS FRENCHIES' PUPPY WARRANTY DISCLAIMER

Your puppy needs a total of 4 puppy shots: 6,9,12 and 15 weeks of age. The last shot should include the rabies vaccine at 16 weeks. If your puppy is with us during the above ages we will make sure the proper shots are given. **Your puppy isn't immune** to any disease until they receive their last puppy shot & rabies. **PLEASE DO NOT TAKE THEM OUT TO ANY PARKS, FAST FOOD RESTAURANT'S GRASSY AREAS, HOTEL GRASSY AREAS, RESTSTOPS ALONG THE INTERSTATE, OR YOUR_VET'S GRASSY AREAS.** Anybody that has a pet vaccinated or NOT lets their dogs relieve themselves in these areas. This is where your pet can catch Coccidia, Guardia, Worms, Parasites or worse Parvo. Please try and keep your new pet confined to your protected personal space until after they are 16 weeks. When you visit your vet make sure you carry him/her in and keep your little one in your lap the whole time you're waiting.

Seller health guarantee warrants that your Frenchie is free of congenital defects of a life threatening nature for TWO (2) years from the dog's date of birth. We do not charge extra for full registration and DO NOT guarantee that your Frenchie will breed. You must disclose to the seller before purchase if you are a breeder of any kind.

I the purchaser understand the warranty information on my new French bulldog. I understand that **I can come to Richmond, Kentucky and visit my French bulldog** any time after they are 7 weeks of age when final payment is due in full on my French bulldog. I agree to take my new puppy to the veterinarian for a well check-up within 2 business days of pick-up /delivery. **If I do not do so I will void my warranty.** I agree to inform Bluegrass Frenchies in writing of the vets findings within 24 hours of the vet visit. **Failure to inform Bluegrass Frenchies within this timeline will void this warranty.** Buyer agrees to email or fax over vet findings to Bluegrass Frenchie. I agree to pick up my puppy by 16 weeks of age. If my puppy is left longer than 16 weeks without written agreement from seller I forfeit rights to my puppy and all money paid on my French bulldog.

I further agree to never sue or bring legal action against Bluegrass Frenchies, Gary McCarty, Kay McCarty or their children without limitations, for or on account of any dispute, property damage, bodily damage, medical expenses, pain and suffering, loss of earnings or profits, or any other kind of expense, contracts, agreements, judgments, claim or demand whatsoever, foreseen or unforeseen, present or future, which I may now have or hereafter have, on account of said dog or time spent on the premises. Such identification shall apply to all unknown and anticipated injuries or said damages as set forth and shall costs and attorney's fees incurred defending against any such claims, whether or not said claims be valid. I agree to pay for all of Gary McCarty, Kay McCarty or Bluegrass Frenchies' legal fees and court costs if I break this agreement and bring any legal action against the kennels or the Frenchies' owners.

Jurisdiction: It is agreed by all parties that all matters related to this agreement shall be brought forth at Madison County, Kentucky under the laws and jurisdiction of the Commonwealth of Kentucky and Madison County courts.

BLUEGRASS FRENCHIES' FINAL PAYMENT OPTIONS

***FINAL PAYMENT OPTIONS:** No matter which option you choose

Final Payment is due when your puppy is 7 weeks of age unless purchased after the age of 7 weeks and then balance is due within 6 days of initial deposit. Face-to-face meetings ONLY. We DO NOT ship our French bulldogs. You may pay in CASH if you wish to visit your puppy at 7 weeks.

Form of Payment Amt. of time we wait before you can get your puppy

***Option 1: No exceptions to this time frame. Pay by 6 WKS to pick up at 10 weeks!**

Personal Check	3 weeks
Money Order	3 weeks
Certified Check	3 weeks

***Option 2: Usually 24-48 hours; due at 7 weeks of age**

Bank to Bank Wire Transfer. When our bank verifies that the funds have cleared our account.

***Option 3: Upon Credit approval, usually gives final approval NEXT day; due at 7 weeks of age**

You can make this payment from our website using your credit card. Go to website and then to "Step 3" Make final payment. You will need to add 3% to cover the credit fees.

***Option 4: Due when your puppy is 7 weeks of age**

Cash- (US dollars ONLY)

You can come in and visit with your puppy at the time that final payment is due if you would like. Please make these arrangements at least 3 weeks in advance if possible so we can set up a day and time that works for both buyer and seller.

Kentucky Sales Tax: This comes from the state not us.

If you live in KY or plan to come to KY to pick up your puppy you'll need to pay 6% KY sales tax. We can usually hand deliver to you if you live in an adjoining state for close to the same price as the tax and save you the time and gas money. Please contact Kay for a price for this service. **If we are hand delivering your Frenchie to you they need to be paid for in full 2 weeks prior to your delivery date.**
